This rate was calculated under the definitions and procedures established by the National Collegiate Athletic Association (NCAA) and reported to the NCAA on the University's 1999 Graduation Rate Disclosure Form in March 1999. The University has determined that this graduation rate information is substantially comparable to the information required under the federal Student Right-to-Know Act.

*\*The information to be disclosed by July 1 of each year is "the graduation rate for the most recent cohort of entering students who all have had an opportunity to complete or graduate from their respective programs" in the specified completion period (which for The University of Alabama is six years).
